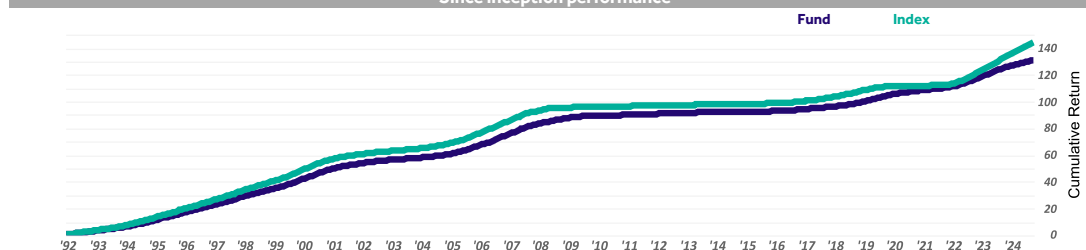

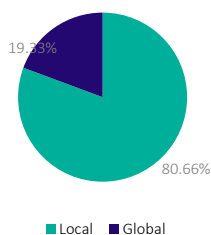

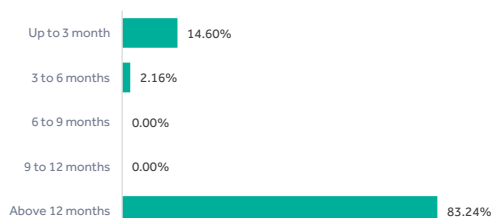
### Since inception performance



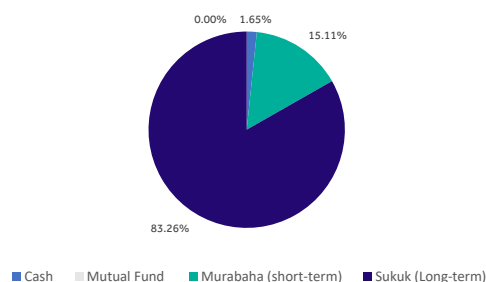
### Geographic Location
