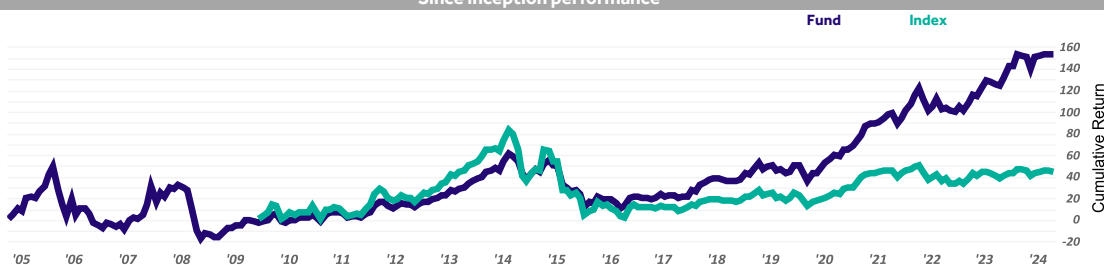


Fund Investment Objective

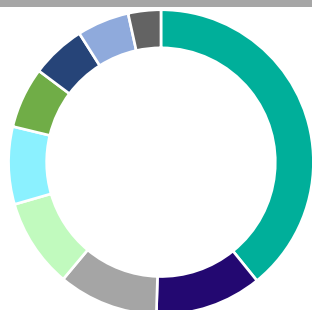
