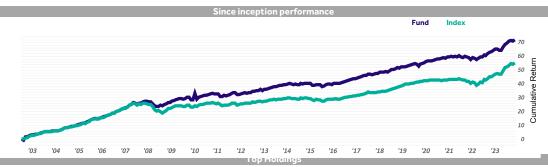


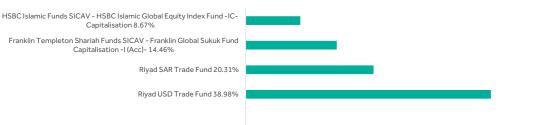
Fund Investment Objective
